MULTIPLE RELATIONSHIPS – CONFLICT OF INTERESTS

A psychologist, Alice, is friends with a couple. When this couple is going through a relation crisis, Alice writes a letter to the man in which she makes some remarks about his girlfriend. When a complaint is filed Alice claims she did not write as a psychologist but as a friend.

An immigrant child in a European country had been assessed, and has been placed to a school for mentally retarded as a result. The family complains after the placement that their child is not mentally retarded and she is bullied by severe retarded kids.



Yeşim Korkut is a professor of clinical psychologist at Acibadem University, İstanbul, and a psychoanalyst. She served long years as the chair of Turkish Psychological Association and currently is the chair of Ethics committee of the PSİKE Psychoanalytical association.



ENGAGEMENT OF THE PSYCHOLOGIST

Vita Poštuvan, SLOVENIA

A psychologist Mitch working in private practice gets involved in a divorce process of parents of 5year old girl. The father comes to ask for help because the court assigned the daughter to the mother, but he has a feeling that mother's father (a grandfather) is sexually assaulting the 5year old girl. Psychologist and the father try many legal actions, but at the end it seems none of them are working. So, the psychologist helps the father to physically take the girl from mother and hide her in a safe place. Once this is known by the media, the public complains.

CONFLICT OF INTERESTS

Miguel Ricou, PORTUGAL

Mother comes with her 7 years old child to see a psychologist. She is getting divorced child's father and believes the child needs help. The mother also says that the father doesn't have confidence in psychology and he will never give consent for these consultations. Psychologist admitted the child into the care. Father complained.

WHEN INTERGRITY LINES ARE CROSSED

Kristina Taylor, SWEDEN

A patient complains about multiple breeches concerning integrity and boundaries from the psychologist, who has engaged in extensive text-messaging by phone with the patient in between sessions, often late at night. The patient also describes how the psychologist often discloses private information about herself and mentions that she is having a "life crises" and that the patient is a comfort to her.



Kristina Taylor works as school psychologist and supervisor. She is the Chair of the Board of Ethics of the Swedish Psychological Association, and is active in professional ethics education of professional psychologists and students.
